1. Assumption of Risk and Release of Liability

I, the undersigned (“Renter”), acknowledge that riding an electric bicycle involves **inherent risks** that may result in **serious injury, permanent disability, paralysis, or death**. These risks include, but are not limited to:

- Changing weather conditions
- Mechanical failures
- Loss of balance
- Variations in terrain
- Collisions with vehicles, pedestrians, or obstacles
- Rider error
- The actions of other participants or third parties

By signing this agreement, I acknowledge that I **voluntarily** participate in this activity with full knowledge and understanding of the **dangers involved**, and I **accept and assume** all risks associated with the use of an electric bicycle / bicycle..

I hereby **release, waive, and discharge** Bike Priority LLC, its owners, employees, agents, representatives, and affiliates from **any and all liability**, claims, demands, actions, or causes of action for **injury, death, or damage to property** arising out of or related to my participation in this activity, whether caused by the **negligence** of Bike Priority LLC or otherwise, to the fullest extent permitted by law.

2. RENTAL TERMS AND CONDITIONS

a. Security Deposit

- A **\$150 refundable security deposit** is required before the rental period begins.
- The deposit will be refunded upon timely return of the bike in satisfactory condition, minus any applicable damage, cleaning, or late return fees.

b. Late Return Fees

- **Up to 2 hours late:** \$50 fee
- **Over 2 hours late:** Full additional day's rental rate applies.
- Late returns can affect subsequent rentals—please notify us immediately if delayed.

c. Pickup and Drop-off Policy

- **On-time pickup and delivery are required.**
- Arriving **more than 30 minutes late** for pickup without notice may result in cancellation and forfeiture of rental fees.
- Early returns are accepted but **do not qualify for refunds** for unused rental time.

d. Cancellation and Refund Policy

- **48+ hours prior to rental start time:** Full refund.
- **Less than 48 hours prior:** No refund. Credit toward a future rental may be offered at Bike Priority LLC's discretion.
- **No-shows:** Forfeit 100% of the rental fee.

e. Weather Policy

- Bike Priority LLC reserves the right to **cancel or reschedule** rentals due to unsafe weather conditions (heavy rain, high winds, storms).
- **Light rain** does not qualify as unsafe.
- If the Renter cancels due to weather concerns not deemed unsafe by Bike Priority LLC, our standard cancellation policy applies.

f. Proper Use

The Renter agrees to:

- Wear a helmet at all times.
- Operate the bike **only on paved roads, bike paths, and designated trails.**
- **No riding on beaches, sand, in saltwater, or off-road.**
- Abide by all traffic laws and regulations.
- **Not** operate the bike under the influence of alcohol or drugs.
- **No subleasing** or allowing others to ride without prior approval.
- Return the bike clean and free of excessive dirt or debris (cleaning fees may apply).

g. Rider Eligibility Requirements

- Riders must be **18 years or older.**
- Riders must be between [**Height Range, e.g., 5'2" and 6'4"**] and under [**Weight Limit, e.g., 275 lbs**], as per manufacturer guidelines.
- Riders should be in **good physical health**, with no medical conditions that could impair safe operation.

h. Battery Charging and Care

- Only use the **provided charger.**
- Do not leave batteries charging unattended or overnight.
- Do not expose the battery or bike to water, extreme heat, or direct sunlight for extended periods.
- Improper handling may result in damage fees up to the full cost of replacement.

i. Damage, Loss, and Theft

- The Renter is responsible for any damage, loss, or theft of the bike and provided accessories.
- If the bike is stolen, the Renter agrees to file a police report and is liable for the **full replacement cost (\$1,800).**

- Repairs and damages beyond normal wear will be deducted from the deposit. If damages exceed the deposit, the Renter will be invoiced for the balance.

3. DAMAGE FEE SCHEDULE (Examples)

<u>Damage</u>	<u>Fee</u>
Lost helmet	\$50
Broken pedal	\$75
Lost lock	\$100
Damaged battery	\$750+
Complete bike theft	\$1,800

4. ZERO-TOLERANCE POLICY FOR ALCOHOL & DRUGS

- Riders **must not** operate e-bikes under the influence of alcohol, drugs, or impairing substances.
 - Violation of this policy results in **immediate termination** of the rental, **forfeiture of all fees and deposit**, and potential legal liability for damages or injuries caused.

5. EMERGENCY CONTACT & BREAKDOWNS

If you experience mechanical issues or an emergency during your ride:

- **Stop riding immediately** and move to a safe location.

 - Do **not** attempt repairs yourself unless otherwise instructed.
 - Assistance or bike swap options will be arranged as soon as possible.
